(2) Mrs. Leslie Lewis, Director of Finance, presented the following memorandum for the Board's consideration:

RE: FY 2013 Lease Purchase

At its meeting of August 27, 2012, the Northampton County Board of Supervisors approved the FY 2013 lease-purchase contract through CFG Community Bank at 1.915% for the three-year term of the lease. Subsequent to that action, the Board approved refinancing of its 2002, 2005, 2006 and 2007 debt, thereby resulting in the County issuing in excess of \$10 million in bank-qualified financings. Because of that, the interest rate had to be modified to 3.25%. (The County had budgeted 3.00% per annum interest rate for the term of this lease.) Correspondence is attached which more fully explains this matter.

Board action is respectfully requested to amend the FY 2013 Lease-Purchase Contract with CFG

Community Bank to reflect the increased interest rate.

I. PROJECTS:

- A. Follow-up on Tall Ships/OpSail Event: I had originally scheduled for the October worksession a discussion and meeting regarding the Tall Ships/OpSail event from this past summer and to look at the financial impact of this event through the Transient Occupancy Tax collections and Meals Tax collections. However, some of this data is still being submitted; therefore, the representatives of ESVAFests have requested to hold this discussion until next month. We will have a completed report for your November 2012 meeting.
- <u>B.</u> Enterprise Zone Map: Reminder to the Board to submit any proposed additions or deletions to the Enterprise Zone Map to my office by October 31, 2012.
- C. Cape Charles Dredging Project: I attended a Planning Charette on Friday, October 12, 2012 that was organized by the Army Corps of Engineers as part of developing the economic justification to support a deeper dredging depth for the Cape Charles Harbor. In attendance were representatives from the Town, Baycoast Railroad, Bayshore Concrete, U.S. Coast Guard, Southport, and other property owners and users of the harbor as well as representation of Rep. Lewis and Rep. Rigell's offices and numerous Army Corps personnel. It was a highly productive meeting and several follow-up tasks assigned to all parties in bringing back specific information to the Army Corps to assist in this analysis. At this time, it is projected that the Army Corps will have a draft analysis completed by early December for our review.
- <u>D.</u> <u>Issuance of 2012 Tax Bills:</u> The tax bills are scheduled for mailing the week of October 22, 2012.

In regards to a discussion of a twice-a-year tax bill, I have pulled the information from our study 2 years ago and am updating that information and will have this item on your November agenda for discussion.
