### *Bid Form*

The bidder, having visited and examined the site and having carefully studied the contract documents and specifications for the replacement of the boat docks located at the Morley's Wharf Harbor located at 2175 Morley's Wharf Road, Exmore, Virginia, does hereby propose to furnish all labor, mechanics, superintendence, tools, materials, equipment and all utilities, transportation and services necessary to perform and complete said work, and work incidental thereto, in a workmanlike manner, as described in said specifications and other contract documents, including addenda issued thereto, in accordance with the prices hereinafter set forth. The bidder, by virtue of this bid, acknowledges receipt of all addenda.

### **MISCELLANEOUS ADDITIONS AND DEDUCTIONS**

The undersigned agrees that the County has the full unconditional right to select any combination of additions or deductions and to adjust the total contract price accordingly.

### **SITE INSPECTION**

The bidder further certifies that he has personally inspected the actual location of the work, together with the local sources of supply, and that he understands the conditions under which work is to be performed, and the special time constraints; or, that if he has not so inspected the site and conditions of the work, that he waives all right to plead any misunderstanding regarding the work required, the bidder's responsibilities, or conditions peculiar to the same.

### **PROPOSAL ACCEPTANCE**

The bidder hereby agrees to hold the bid price without change for a period not to exceed sixty (60) days, and further agrees to begin and complete all work covered by the plans and specifications within the time limits set forth in the contract documents.

### **SCHEDULE**

The County desires commencement and completion of work as specified in the contract documents. The bidder's ability or inability to meet the schedule is a material factor that will be taken into consideration in the evaluation of bids and award of this contract.
